State of the City and County Luncheon (March 2016)

Presents an overview of area business trends. The Small Business Person of the Year is recognized.

Business After Hours

We secure and conduct BAH programs to provide informative networking opportunities in an informal social setting. Usually 12 programs each year.



Chamber Fall Golf Classic (September 2015)

We will continue to improve our golf outing events into more attractive and enjoyable networking opportunities.



Chamber Spring Golf Classic (May 2016)

We will to continue the tradition of an excellent golf outing event, rotating our use of local courses. Again, our events provide a wonderful and enjoyable networking opportunity.

Administrative Professionals' Day Luncheon (April 27, 2016)

This program is a terrific opportunity for member businesses to recognize and reward their administrative staff by attending a luncheon celebration that provides sponsor booths and free gifts and prizes.



GOVERNMENT AFFAIRS

A key part of the Greater Florence Chamber of Commerce's mission is to promote and enhance a favorable business climate and to make Florence the best community in which to live and operate a business. To that end, we will use our Government Affairs Council to be a voice in the halls of local and state government. This would include policy issues, regulations and ordinances of government.

Legislative Breakfast – Education Initiatives (September 2015)

We invite our legislators to meet Chamber members and community leaders in a formal setting. It is an excellent way to build and grow relationships and to update the community on business and educational efforts. Lawmakers can explain the work they are doing on behalf of their constituents in these two important areas. We want to become a trusted resource that members can turn to when they need information.



Legislative Breakfast – Small & Minority Issues (February 2016)

Similar to our fall program, we invite our legislators to meet Chamber members along with community leaders in a less formal setting. The sessions can help educate our local businesses on issues and on efforts to eliminate the operational hurdles for the small and minority business operators.

Legislative Day (March 2016)

This is our annual business showcase conducted in Columbia, SC. This is a joint effort of the Greater Florence Chamber of Commerce and the Florence County Economic Development Partnership. Together, we co-host a luncheon with Florence County leaders and the current year's Leadership Florence group. The day also includes an evening reception hosting our state and local elected officials.



City/Chamber Business of the Quarter (Awarded at City Council meetings during the first, second, third and fourth quarters)

A joint award made possible by the Chamber of Commerce and the City of Florence. The award is presented quarterly to a local business recognizing its efforts to help redevelop downtown Florence.



Washington Trip (April 2016)

A bi-annual visit to our region's legislative delegation in Washington, DC. The visit provides time to discuss present issues and topics of concern in the Pee Dee.



COMMUNITY& BUSINESS DEVELOPMENT

The activities of this division encompass community and local business outreach. It has at its core, programs that focus on community betterment and local business opportunities for companies, small business and minority business operators.

Promoting the Inclusion of Small and Minority Businesses (PRISM, Ongoing)

A committee focused on developing action plans, events and programs focused on the inclusion of small and minority businesses.

Chili, Brews & BBQ (October 23-24, 2015)

An opportunity for the Chamber to provide a communitywide, family-friendly event that promotes the Chamber, its members and Florence as a whole.



Quarterly Business Seminars (Ongoing)

A regular series focusing on current business issues and providing helpful information on how to tackle and address problems dealing with those topics.

Small & Minority Business Showcase (Summer 2015)

Provides local professionals the opportunity to display their business among other Chamber members and the local community. The venture allows small and minority businesses to highlight their goods and services.

CEO Roundtable (Mar. June, Sept. Dec.)

Hosted by Willcox, Buyck & Williams Law Firm. this breakfast is an informational exchange for senior business executives. It is held quarterly and typically has 25 local leaders in attendance.



Santa Run (December 2015)

This new, family-friendly 5K will offer participants the chance to put on a red race shirt, Santa hat and spread cheer throughout the streets of downtown Florence. It will be a chip-timed race, complete with an aid station and post-race food and drink. Participants will receive a long-sleeved, red race shirt and their very own Santa hat. Overall winners will receive medals; top age group finishers will also receive recognition.

Shop Local Program (Ongoing)

A program conducted in conjunction with a local media outlet, that promotes shopping with local businesses to the public. This program usually starts during the holiday shopping season, but we would like to expand it to a year-round program.



EDUCATION / LEADERSHIP

The Chamber believes strong educational opportunity is a key factor in the development of our local economy. Excellence in schools, colleges and universities is critical to building a modern and durable economy. The Florence Chamber will be focused on expanding learning programs which will enhance the education processes available in the Pee Dee Region.

Leadership Florence (September 2015)

This program helps develop effective leaders who will strengthen and transform our community. The class of approximately 30 participants reflects the diversity of our community-at-large. It is a hands-on program that includes team-building experiences and allows interaction with local business, media, government and education.




Leadership Florence Alumni Association (Ongoing)

A continuation program that fosters relationships among graduates of the Leadership Florence Program while also allowing them to stay abreast on current issues and stay engaged in community service. This includes quarterly meetings, networking socials and informative conferences.

Building Bridges (February – March 2016)

This program helps to engage our community by addressing racial and cultural diversity through a structured process. It helps to change attitudes and minds through educational and consciousness-raising sessions with emphasis focused on the workplace.



Junior Leadership Florence County (September-May 2015)

The JLFC Program is a new, prestigious opportunity for our county's high school sophomores and juniors who desire to become engaged citizens. The program was adopted from successful junior leadership programs in South Carolina, along with input from local education leaders. Each year, 20-24 students will be selected to participate in the program from all of the counties' high schools, which include rural, urban, public, private, home and virtual-schooled students. These students will spend 10 months going through a curriculum designed to broaden their leadership horizons.



Emerging Leaders Summer Institute (June 2016)

A five-week program designed to enhance leadership skills within the small and minority business community of professionals. This program will help share effective leadership opportunities at a very cost-effective level.



BUDGET & FINANCE

This division oversees the administrative and financial planning, procedures and policies of the Chamber. It will provide guidance in the administration of staff duties, manage facilities and equipment as well as manage the membership dues and retention efforts of our members.

Budgeting

We develop budgets to ensure sound financial management practices for the Chamber programs and the Pee Dee Visions 501-C3.

- Division members develop the annual budget and submit it to the Chamber Board for adoption during our May board meeting.
- We review the financial status of the Chamber on a monthly basis and review the CPA firm's year-end financial audit and will also review the management letter in September to ensure implementation of approved recommendations.

Ambassadors Committee

Fosters goodwill and understanding of the Chamber programs to existing and new members. This group can represent the Chamber at a variety of local events and also provide support for Chamber programs including:

- Acting as hosts at various Chamber events.
- Helping staff at Chamber functions.
- Hosting grand openings for Chamber members.
- Orientation of new members at various Chamber events.





Board of Directors Meetings

The Board of Directors meets the third Thursday of each month with the exception of July and December.

Chamber Affinity Programs
