**Setup:** *Setup begins Friday, October 21, 2022 at 2:00 PM.*

**Health Codes:** All contestants must adhere to all health, electrical, fire, and other codes applicable to this event.

**Canopies/Tents:** Canopies/Tents are welcomed and encouraged. Tent must be no more than 10 feet deep.

**Application Procedure:** Applications are accepted on a first-come, first-serve basis. The Florence Chamber reserves the right to deny any application, at any time.

**Damage Waiver:** By completing the agreement below, you agree that the Pee Dee Visions Foundation, the Florence Chamber and the Florence Downtown Development Corporation, its parent subsidiaries and their respective shareholders, officers, directors, employees, agents and assigns, **WILL NOT** be liable for any loss or damage from any cause.

**Meat and Materials:** At least 120 lbs. of refrigerated and pre-cut wings will be distributed to each team before the cook's meeting. You may be asked to cook additional wings. You must provide all materials for your cooking needs. The Florence Chamber will provide trays for guest sampling.

**Electric and Water:** Standard 110 volt / 220 amp electrical power and water connections will be provided where available. Vendors needing additional voltage or power will need to coordinate their needs with the Florence Chamber PRIOR to the event. Vendor is responsible for providing all needed extension cords. **(100 feet minimum)**

**Wing Samples Defined As:** 1 piece for 1 ticket, 4 pieces for 3 tickets and 7 pieces for 5 tickets. Any and all Wings that remains following your entry, will be served to those in attendance from your cooking site. All Sales will be by tickets sold by the Florence Chamber.
